39th ATLANTA MODEL TRAIN AND RAILROADIANA SHOW**

The 39th Atlanta Model Train and Railroadiana show will be held Saturday, August 14, 2010 from 9:00 AM to 4:00 PM at the **North Atlanta Trade Center, 1700 Jeurgens Court, Norcross, GA, 30093**. This location is just east of Atlanta and I-285 and is easily accessible from I-85. The Trade Center has been the location for a variety of shows for a number of years and is highly recommended as an excellent site for our show!! The Center has 1,400 parking spaces in its parking lot and **PARKING IS FREE!!** There are a number of good motels along I-85 in the Norcross area.

For dealers, set up for the Model Train and Railroadiana Show will be from 11:00 AM to 5:00 PM on Friday, August 13 and 7:00 AM to 9:00 AM on Saturday, August 14. We expect to sell out the 39th Show with over 300 tables. We are advertising the show on the Internet and in the major railroad, railroadiana, and model publications, and local newspapers. Show flyers will be distributed at railroadiana/model shows, hobby shops, antique shows and malls, and flea markets, and will be mailed to over 3,000 potential attendees on our mailing list.

All tables must be paid in advance. Table locations will be assigned in the order payment is received. Return the Rental Agreement signed and include a large self-addressed stamped envelope. If a large self-addressed stamped envelope is not enclosed, then your paid contract receipt can be picked up at the show. Make checks payable to Golden Spike Enterprises, Inc. Return the contract fully completed, except for the receipt acknowledgment area, with your payment to Charlie Miller, 3106 North Rochester Street, Arlington, VA 22213-1348.

Early admission for non-dealers will be available for \$20.00 per person. Early admission provides access to the hall at all times dealers are in the hall (set up times and public hours) without requiring rental of a table. Those purchasing early admission are issued a badge that must be worn at all times when only dealers are in the hall.

There is a charge for electrical hookups. If you need electrical service, the price per service is \$25.00 in advance (at least ten days before the show) and then \$40.00 per connection less than 8 days prior to or on show day. **To get the advance rate of \$25.00, we must have your electrical payment no later than August 7, 2010 - no exceptions please.** We will make arrangements for your electrical service to your table(s) if you include the proper payment with your table reservation.

To Reach the North Atlanta Trade Center:

From I-85 Northbound (Alabama/Columbus, GA) or the Hartsfield Airport's Main Terminal: I-85 North through Atlanta and go approximately 3 miles north of I-285 to the Indian Trail Exit (Exit 101). Turn right on Indian Trail and go approximately ¼ mile to Oakbrook Parkway. Turn right on Oakbrook Parkway and go approximately ½ mile to Jeurgens Court. Turn right on Jeurgens Court and follow road into the facility's main parking lot. The Trade Center is at the north end of the parking lot.

From I-85 Southbound (South Carolina/Gainesville, GA): I-85 South to the Indian Trail Exit (Exit 101). Turn left on Indian Trail and go approximately ¾ mile to Oakbrook Parkway. Turn right on Oakbrook Parkway and go approximately ½ mile to Jeurgens Court. Turn right on Jeurgens Court and follow road into the facility's main parking lot. The Trade Center is at the north end of the parking lot.

From I-75 Northbound (Florida/Macon, GA): I-75 North to I-675. Continue north on I-675 to I-285. East/North on I-285 to I-85. North on I-85 approximately 3 miles to the Indian Trail Exit (Exit 101). Turn right on Indian Trail and go approximately ¼ mile to Oakbrook Parkway. Turn right on Oakbrook Parkway and go approximately ½ mile to Jeurgens Court. Turn right on Jeurgens Court and follow road into the facility's main parking lot. The Trade Center is at the north end of the parking lot.

From I-75 Southbound (Tennessee/Marietta, GA): I-75 South to I-285. East/South on I-285 to I-85. I-85 North approximately 3 miles to the Indian Trail Exit (Exit 101). Turn right on Indian Trail and go approximately ¼ mile to Oakbrook Parkway. Turn right on Oakbrook Parkway and go approximately ½ mile to Jeurgens Court. Turn right on Jeurgens Court and follow road into the facility's main parking lot. The Trade Center is at the north end of the parking lot.

From I-20 Eastbound (Alabama/West GA): I-20 East to I-85. I-85 North through Atlanta and go approximately 3 miles north of I-285 to the Indian Trail Exit (Exit 101). Turn right on Indian Trail and go approximately ¼ mile to Oakbrook Parkway. Turn right on Oakbrook Parkway and go approximately ½ mile to Jeurgens Court. Turn right on Jeurgens Court and follow road into the facility's main parking lot. The Trade Center is at the north end of the parking lot.

From I-20 Westbound (South Carolina/Augusta, GA): I-20 West to I-285. I-285 North to I-85. I-85 North approximately 3 miles to the Indian Trail Exit (Exit 101). Turn right on Indian Trail and go approximately ¼ mile to Oakbrook Parkway. Turn right on Oakbrook Parkway and go approximately ½ mile to Jeurgens Court. Turn right on Jeurgens Court and follow road into the facility's main parking lot. The Trade Center is at the north end of the parking lot.
